PREFACE

The Assam Legislative Assembly adopted a Resolution on 5th July, 1957 for examining the Rules of Procedure then in force and to bring them at par with the Rules of Procedure and Conduct of Business in Lok Sabha. The Rules Committee, Assam Legislative Assembly, headed by the then Hon'ble Speaker presented its final Report to the Assembly which was adopted by the House on 12th December, 1957. The First (Revised) Edition of the Rules of Procedure and Conduct of Business in Assam Legislative Assembly was issued in 1957. Since then considerable amendments were made to the Rules and the Tenth Edition of the Rules of Procedure and Conduct of Business was issued in February, 2006 as modified.

Since publication of the Tenth Edition of the Rules of Procedure and Conduct of Business in Assam Legislative Assembly in February, 2006, certain amendments have been made to the existing Rules during the 12th Assam Legislative Assembly. The amended rules as recommended by the Rules Committee, Assam Legislative Assembly, were presented to the House on 10th July, 2006, 11th December, 2006, 26th February, 2007, 13th July, 2009 and 1st February, 2011.

It has been decided to bring out the Eleventh Edition of the Rules of Procedure and Conduct of Business in Assam Legislative Assembly incorporating the amendments before the constitution of the 13th Assam Legislative Assembly in May, 2011.

I am grateful to the Hon'ble Speaker, Assam Legislative Assembly, and the Hon'ble Chairman of the Rules Committee Shri Tanka Bahadur Rai for his valuable advice and suggestions and for his kind consent to publish the Eleventh Edition of the Rules of Procedure and Conduct of Business in Assam Legislative Assembly incorporating the amendments as recommended by the Rules Committee and adopted by the House.

It is hoped that it will be useful for the Hon'ble Members of the House, Political thinkers and others with the amendments incorporated in this Eleventh Edition.
